## 2018 Soil Health Cost-Share Program for Micro-Farms and Gardens

Soil and Water Conservation Districts (SWCDs) are in place to help people help the land. The Soil Health Initiative is a program to provide technical and financial assistance to improve soil health and water quality through soil conservation practices, with a focus on small farms and gardens in Marion and Hendricks Counties. The cost-share program is made possible through [Clean Water Indiana](#) competitive grant funds awarded to the SWCDs.

Soil health is the continued capacity of soil to function as a vital living ecosystem that sustains plants, animals, and humans. Soil health is improved with conservation practices and 4 guiding principles:

1. Minimize Disturbance – *Disturb the soil as little as possible.*
2. Maximize Soil Cover – *Keep the soil covered as much as possible.*
3. Maximize Biodiversity – *Using crop rotation and cover crops.*
4. Provide Continuous Living Roots – *Keep plants growing throughout the year.*

### Cost-Share Program Overview

Cost-share funds to help growers improve soil health are available through a competitive application process. Applications are reviewed monthly and evaluated on the applicant's ability to complete the project, availability of program funds and assistance, benefits to soil health and water quality, and educational opportunity. The application window may close on May 1 or before if program capacity is met. Land less than 20 acres and projects exceeding \$200 will be a priority.

The SWCDs will notify the applicant of grant status once a determination is made or contact the applicant if additional information is needed. The SWCD will work with the top applicants to conduct a site visit, develop a plan for conservation practices, a budget, material sourcing options, and a cost-share contract to affirm the appropriate amount of grant funding and project timeline. Final approval for financial assistance will then be determined by the Soil and Water Conservation District's board of supervisors. Contracts are effective upon signed agreement of terms by both parties.

This is a reimbursement program for eligible materials purchased by the recipient and implemented under an approved timeline and contract. Recipients will be responsible for material purchasing, proper installation and maintenance of conservation practices. Practices will be completed in 2018 or by the timeline approved by the SWCD at the time of contract. Materials eligible for reimbursements should not be made outside of the approved timeline. Reimbursements will be made based on submitted receipts.

## Conservation Practices and Funding

Conservation practice materials eligible for funding are listed in the following table. The SWCD match indicates the percentage of the cost to be reimbursed to the recipient after project implementation and submittal of receipts. The SWCD reimbursement maximum for cover crops is \$50 per acre. The reimbursement maximum for other practice categories will be determined in the contract and based on planning and budgeting completed with SWCD. There is no predetermined acreage or funding limit per applicant. Conservation practices will be implemented according to Natural Resources Conservation Service standards and local laws and ordinances.

Conservation Practice Materials		SWCD Match
<b>Cover Crops</b>	<ul style="list-style-type: none"> <li>- Cover crop seed</li> <li>- Inoculant</li> <li>- Shipping costs</li> </ul>	75% up to \$50/acre
<b>Mulching</b>	<ul style="list-style-type: none"> <li>- Vegetative mulch or other material approved by the SWCD. Examples include straw, hay, and paper.</li> </ul>	75%
<b>Soil Testing for Nutrients</b>	<ul style="list-style-type: none"> <li>- Laboratory fees</li> <li>- Nutrient recommendation fees</li> <li>- Shipping costs</li> </ul>	75%
<b>Native Plantings</b>	<ul style="list-style-type: none"> <li>- Plants and/or seed</li> </ul>	75%
<b>Equipment</b>	<ul style="list-style-type: none"> <li>- Preapproved equipment purchase</li> <li>- Preapproved equipment rental</li> <li>- Shipping costs</li> </ul>	50%
